Question 20

Reference: Amendment 002

The response to Question 16 says "See changes to the RFP below."

We assume this means your response is affirmative, that the Crown will accept a Certified Change Management Professional Certification (CCMP) to satisfy this requirement. But, we don't see any changes to R1 below, only for R2.

Question 21

On page 120, under Change Management Consultant R2, Canada asks that the proposed resource should have an SAP certification. As outlined in the Statement of work "The Contractor will provide Informatics Professional Services in support of current and future TBS projects related to SAP S4/Hana platform."

Canada also states that "other government departments and agencies may require the Contractor's services to implement the common financial management system."

In order to evaluate the Change Management Consultant category and their experience related to SAP S4 Hana, an SAP certification may not mitigate any risk to the Crown that the Bidder has the experience required to perform the tasks with sound insights from previous engagements. Would Canada consider replacing this requirement with the following:

- a. The resource should either hold a valid SAP Certification or have experience of one (1) or more S4/Hana projects within the last 3 years prior to the solicitation issuance date of this RFP.

On page 121, under Project Executive, Canada requests that the proposed resource one recognized professional certification in the following:

- Project Management Professional (PMP);
- Certified Associate in Project Management (CAPM);
- Program Management Professional (PgMP);
- Portfolio Management Professional (PfMP);
- Project Management Institute (PMI) Agile
- Certified Practitioner (PMI-ACP);
- PMI Professional in Business Analysis (PMIPBA);

- PMI Risk Management Professional (PMIRMP);
- PMI Scheduling Professional (PMI-SP)

While a significant portion of the activities related to the FMT opportunity are centered around the Financial system and related data, scope element 3.3. clearly states the importance of a streamlined, standardized approach to financial management which stems from leading practice finance processes. An individual with a CPA/CMA understands these financial processes, how financial data flows through the processes and across processes, enabling them to effectively challenge current state practices and design a future state that will generate timely, accurate financial information that can be used to drive insights and support effective decision-making. Furthermore, FMT includes the implementation of Accrual Budgeting, which is a new approach for government. Having a solid understanding of the processes and principles that underpin this approach will help Canada facilitate stakeholder adoption and support leading practice design.

Would Canada consider including a CPA, CMA or equivalent to the list of acceptable certifications?

Would Canada consider replacing this requirement with the following:

The resource should either hold a valid SAP Certification or have experience of one (1) or more S4/Hana projects within the last 3 years prior to the solicitation issuance date of this RFP.

Question 25

The response to this question states "Before award of a contract, the Bidder's proposed individuals must have a Secret Clearance."

The SRCL attached to the RFP notes both Reliability and Secret, in keeping with the resulting contract for "as and when" resources, as different engagements might have different security requirements that could be noted in individual TAs. In addition, Part 7 Resulting Contract Clauses, Clause 7.5 states "The Contractor personnel requiring access to protected/classified information, assets or sensitive work site(s) must EACH hold a valid personnel security screening at the level of Reliability Status, Confidential or Secret as required, granted or approved by CISD/PWGSC."

Please confirm that the response to Q1 should read "The Bidder's proposed individuals must have a minimum of Reliability status at the time of bid submission."

Answer 25

Canada confirms that all proposed resources must have a security clearance at the level of Reliability Status or Secret at Contract Award.

Question 26

M1 for the Project Executive Level 3 state the proposed resource has a minimum of one hundred and twenty (120) months of Project Management or Change Management experience or sixty (60) months of Change Management experience with a relevant recognized professional project or change management professional certification leading complex transformational initiatives performing at least three (3) of the following tasks:

viii. Complex Enterprise Resource Planning software, Enterprise COTS or similar software

x. Advisory role to senior executive capacity

xi. Managing more than two (2) project managers

For the role of a Project executive, Change Management experience is not relevant and would not provide the breadth and depth of experience required for this position. In addition to this, there is a Change Management role within this response that would cover off the required Change Management experience needed for the project. Would the crown consider changing the requirement to read "the proposed resource has a minimum of one hundred and twenty (120) months of Project Management or Project Executive experience leading complex transformational initiatives performing at least three (3) of the following tasks:

viii. Complex Enterprise Resource Planning software, Enterprise COTS or similar software

Re: Attachment 4.2; Project Manager, Level 3; R2;

R2 states: *"The bidder should demonstrate that the proposed resource has experience within the last 5 years prior to the solicitation issuance date, managing or contributing to the management of Task Authorizations."*

We request the following confirmation and clarifications:

- a. "Task Authorizations" are a method of supply specific to the Government of Canada. Private organizations use similar methods however, these are generally called Purchase Orders or Work Orders. Only accepting "Task Authorizations" will unfairly exclude qualified resources with private sector experience. To ensure a competitive procurement process with a larger pool of highly qualified resources, please confirm that experience managing or contributing to the management of Purchase Orders and/or Work Orders will be acceptable for R2.

- b. We request clarification regarding how the Crown defines "managing or contributing to the management of" Task Authorizations (TA). For example, it is not clear if the Crown is referring to financial management (e.g. tracked spending on a TA) or for the management of consultant resources, or something else. Please provide a clear description of the Crown's meaning of "managing or contributing to the management of Task Authorizations".

Prosci is the industry standard for change management practitioners worldwide. Prosci is a widely recognized professional change management certification that is also recognized by the PMI institute as eligible for 24 PDU's. Accepting only the six certifications listed in R1 is extremely limiting and excludes highly qualified resources with relevant experience and similar certifications from competition. To ensure a competitive procurement process with a larger pool of highly qualified resources, will the Crown please accept the Prosci certification as acceptable to meet R1?
