AMENDMENT 001

This amendment aims to answer to a question and to modify the article 1.4.2.5 from the annexes A & C, and also to modify the article 2.5 – Optional Site Visit.

Q1: We have a question regarding the article 1.4 Contractor qualifications. In section 1.4.2.5, we have to demonstrate that we have designed and commissioned hydraulic test bench systems valued at over \$750,000.

Our hydraulic centre has designed test benches of similar complexity, but for amounts under \$750,000. Would it be possible to accept examples of lower value and size hydraulic test stands while also accepting references from hydraulic projects in other than test stands for values greater than \$750,000?

A1: Yes.

The article 1.4.2.5 of the Annexes A and C is modified as follows:

Delete

1.4.2.5 The value of the project must be greater than \$ 750,000.

Insert:

1.4.2.5 The value of the project must be greater than \$ 750,000. Test benches of similar complexity, but for amounts less than \$ 750,000 are also accepted if the supplier is able to provide references for hydraulic projects other than test benches for values greater than \$ 750,000.

The article 2.5 Optional Site Visit is amended as follows:

Delete article 2.5 in its entirety and replace with the following:

Insert:

2.5 Virtual Site Visit (Optional)

It is recommended that the Bidder or a representative of the Bidder attend the virtual work site visit. Arrangements have been made to host the virtual site visit on **November 3, 2020**. The virtual site visit will begin at 10:00 EST.

Bidders must communicate with the Contracting Authority no later than **October 30, 2020**, to confirm attendance and provide the name(s) and the e-mail address of the person(s) who will attend. All the information needed to have access to the virtual meeting will be then be provided as well as instructions on how to connect. No alternative appointment will be given to bidders or their representative who do not attend. Bidders who do not participate in the virtual visit will not be precluded from submitting a bid. Any clarifications or changes to the bid solicitation resulting from the virtual site visit will be included as an amendment to the bid solicitation.

All other terms and conditions remain unchanged.
