This solicitation amendment has been raised to make the following changes and clarifications:

On Page 1 under Time Zone,

DELETE:

Mountain Daylight Saving Time MDT

INSERT:

Mountain Standard Time MST

Question 1:

If a firm is submitting for all 4 zones do they have to provide Project Experience (Section 3.2.3) for all 4 zones separately (12 projects total) or are proponents to provide 3 projects maximum no matter how many zones they are submitting for?

Answer 1:

In 3.2, it states "Evaluation for Sections 3.2.1, 3.2.2, 3.2.3 and 3.2.6 will apply to all zones being bid on." Therefore, only a maximum of three (3) projects are required.

Question 2:

Will PWGSC be awarding zones individually even if a firm submits for all zones? I.e. Could a firm submit for AB North, AB South, SK and MB, and only be awarded one of the four?

Answer 2:

Yes. Up to 4 Standing Offers may be issued in each zone. They will be recommended based on the ranking of each bidder per zone.

Question 3:

Can PWGSC please confirm if all call-ups will be a DB methodology and if yes, how do you envision partnering contractor with designer at time of call-up? If not, can you please confirm all anticipated project delivery methods?

Answer 3:

Call-ups will not be a DB methodology. PWGSC will use the design-bid-build methodology for call-ups resulting from this process.

Question 4:

Please confirm that key personnel listed do not have to have Secret clearance at the time of closing, and can apply for this clearance after award?

Answer 4:

Correct. Security clearance is not required at bid close.

Question 5:

It is customary for RFPs to include Consultant Team Identification Forms. This has not been included in the RFP. Can you please confirm that this form will not be required?

Answer 5:

Correct, this is a Request for Standing Offer (RFSO) and the Team Identification Form is not required.

Question 6:

For 3.2 Rated Requirements, it is stated that "Evaluation for Sections 3.2.1, 3.2.2, 3.2.3 and 3.2.6 will apply to all zones being bid on. Evaluation for Sections 3.2.4 and 3.2.5 will apply to the specific zone being bid on." Does this mean that we do not have to submit separate responses for sections 3.2.1, 3.2.2, 3.2.3 and 3.2.6 for each Zone we are bidding on?

Answer 6:

Correct. A bidder who is submitting for multiple zones will only need to complete 3.2.1, 3.2.2, 3.2.3 and 3.2.6 once.

Question 7:

Is there a page limit that we have to follow for the hypothetical projects? Or are we free to include as many pages as required, so long as we don't surpass the overall page count provided in section 2.5?

Answer 7:

A bid must follow the instructions provided in Section 2.5. No specific page limit has been identified for section 3.2.6 Hypothetical Projects.

Question 8:

In Item 3.2.6 Hypothetical Projects, 2 b) asks to include the number of hours for identified resources, but also specifies that the calculation of a fee for the provision of these services is not required. Is the intent that the number of hours are listed, but hourly rate for each position be omitted in the work breakdown structure?

Answer 8:

Correct, a bidder is to provide a summary of proposed work breakdown structure i.e. the level of effort in terms of number of hours of all identified resources – and – calculation of a fee for the provision of these services is not required."

Question 9:

Can we add resumes of additional team members in an appendix?

Answer 9:

It is the bidders responsibility to ensure the requirements are met. All information will be subject to SRE 2.

Question 10:

Are we able to include an org chart that shows our larger team, or is the org chart only to include the key people identified in this RFP

Answer 10:

In accordance with SRE 3.2.2.2, the Offeror should provide a description of the management and organization (reporting structure) as it applies to delivery of the Required Services. It is the offerors choice on how to represent that.

Question 11:

Please confirm that printed copies are not required to be submitted along with the digital epost Connect submission.

Answer 11:

Correct, physical copies will not be required if submitting through ePost.
