### Amendment 007

Amendment 007 is raised to:

- A. Amend Article 2.11 Submission of Responses; and
  - B. Provide answers to enquiries from industry.

#### A. **Amend Article 2.11 Submission of Responses, paragraph 13**

DELETE Article 2.11 paragraph 13 in its entire and REPLACE with the following:

13. A Response transmitted by epost Connect service constitutes the formal Response of the Respondent. However, Respondents may choose to also submit a hard copy of their Response to the PWGSC Bid Receiving Unit as indicated in paragraph 1 above in addition to a Response submitted via epost Connect. If a Respondent submits their Response in both hard copy and by epost Connect, the following order of precedence will apply to any discrepancies in the Response as submitted:
- (a) The hard copy Response will take precedence over the epost Connect Response;
  - (b) For any revision submitted pursuant to Article 2.14 Revision of Response:
    - i. a revision that is clearly marked with a later revision number will take precedence over an earlier revision, regardless of how it is transmitted (for example: a revision clearly marked with "Revision 2" will take precedence over a revision marked "Revision 1");
    - ii. if revision numbers are not clearly marked, or a revision bearing the same number is submitted by both hard copy and by epost Connect, the hard copy revision revision(s) will take precedence over the epost Connect revision(s); and
    - iii. in the event a discrepancy between the Response formats impacts the interpretation of a revision, the revision will be deemed to amend the hard copy Response, regardless of how the revision was transmitted.

Was there a reason for providing the extension?</p>	<p>To provide clarification for the closing date, please note Amendment 005 extended the closing date to October 29th and Amendment 006 extended the closing date again to November 5th.
