## REQUEST FOR QUOTATION AMENDMENT NO. 001

Request for Quotation Amendment no. 001 is raised for the following reasons:

- To address vendor questions
- To amend clauses
- To add a requirement to the SOR

### Question 1

As listed in the List of Deliverables, Line item 1, under Generic Description: “Must be compatible with Lenovo Model T460”, would the Crown please clarify which particular Model of the Lenovo T460(T460, T460P, T460S) this refers to, as these different models don’t necessarily use the same memory?

### Answer 1

Lenovo Thinkpad T460 is what we have, the technical specs on the RAM are 8GB DDR3 SODIMM 1600Mhz PC3L-12800 NON-ECC, as long as they have that spec they will be compatible.

**Delete in its entirety and replace with:**

- a) **Contract Period:** The “**Contract Period**” is the entire period of time during which the Contractor is obliged to perform the Work, which includes:
  - (i) The “**Initial Contract Period**”, which begins on the date the Contract is awarded and lasts to provide warranty services for the term of the warranty.
