## AMENDMENT 001

Amendment No. 1 is being raised to make the following changes:

At Part 4 – Evaluation Procedures and Basis of Selection, Article **4.1.2 Financial Evaluation**, Article **4.1.2.1 Mandatory Financial Criteria**, **B. All Other Offerors**, Article B.2:

**Delete:** in its entirety.

**Replace with:**

“B.2 Offerors must submit their financial offer in accordance with the Annex B, Basis of Payment and with the spreadsheet for each of their offered Areas available under “Download and complete Financial Offer” at: <https://ont-sat-ths.tpsgc-pwgsc.gc.ca/docs/index-eng.cfm#dt-tg>.”

The prices must be an all-inclusive firm hourly rate in Canadian funds excluding applicable taxes but including salary, overhead, profit, benefits, annual leave, sick leave, security clearance, processing cost etc., for the provision of a temporary help unilingual English speaking resource. Only one firm hourly rate is to be provided per classification, per category, per geographical area in order to be deemed responsive for the line item. (Note: the Offeror should complete the “Company profile and contact information” section on each spreadsheet).

At **Part 4 – Evaluation Procedures and Basis of Selection**, Article **4.1.2 Financial Evaluation**, Article **4.1.2.2**:

**Delete:** in its entirety.

**Replace with:**

“**4.1.2.2.** Firm hourly rates below the minimum wage for the respective Province/Territory will be deemed non-responsive for the line item and will be automatically removed and not evaluated any further.”

At **Part 4 – Evaluation Procedures and Basis of Selection**, Article **4.2 Basis of Selection**:

**Delete:** in its entirety.

**Replace with:**

**“4.2 Basis of Selection**

**4.2.1** An offer must comply with the requirements of the Request for Standing Offers and meet all mandatory technical and financial evaluation criteria to be declared responsive. The responsive offer with the lowest evaluated price on an item by item basis will be recommended for issuance of a standing offer.”
