Questions and Answers

Note: Answers to questions 1-2 were provided in Solicitation Amendment 001. Answers to questions 3-9 were provided in Solicitation Amendment 002.

Q10: What is the anticipated award date of this solicitation?

A10: Canada anticipates that a contract may be awarded in December. All contract awards are subject to Canada's internal approval processes.

Q11: The resource grids require Bidders to quote the page number in the resume that demonstrates the candidate's experience for each requirement. This is always a challenge as final pagination is never accurate until the final changes are made to the response document, and it is therefore highly prone to last minute errors. Bidders typically number each project within the candidate's resume. Please confirm that Bidders may quote the project number within the resume as opposed to the page number.

A11: Bidders are requested to reference, as accurately as possible, where in their bid the information demonstrating compliance is located. Quoting a page number is just one example of a number of ways that Bidders may choose to include references in their bid, and using other methods of including references, including referencing project numbers, is acceptable.

Q12: On October 9th, we asked whether the proposed resources had to have "Secret Clearance" and it was confirmed that they did. Addendum 2 issued today, seems to reverse this position with Reliability Level clearance now being the requirement rather than Secret. Nearly 20 days have been lost since our clarification request. Now we may be able to respond however the **November 6th** submission timeline is too tight. Please advise if an RFP extension is being considered.

A12: The bid closing date has been extended to November 19, 2020 at 2:00PM.

Q13: Should our organization have the right Skills to propose in Canada, but currently without Reliability Clearance, should we respond and initiate the 330-23 Reliability Clearance process in parallel?
