- **1.1** Elections Canada hereby amends in accordance with this amendment the Invitation to Qualify for Regional Media Advisor Services bearing number ECTD-ITQ-0321 and dated October 8, 2020 (the "ITQ"). This amendment hereby forms part of the ITQ.
- 1.2 Unless defined herein or unless the context otherwise requires, all of the words and phrases defined in the ITQ and used in this amendment shall have the same meanings assigned to them in the ITQ.

The following question(s) have been asked in response to the Invitation to Qualify and Elections Canada hereby answers as follows:

2.1 Question No. 11

Question:

- a) I understand I am submitting a separate document for the following. Could you please confirm if I am correct?
 - •M1-CV
 - •M2 Language requirement. I am now submitting Amendment 3 where I check the correct box French or English.
 - •M3 two media releases
- b) Part 6 Information I understand that I will copy all of the information on this page into a new document, fill in the details under 6.2.3 and provide this as a separate document in my application.
- c) Response Submission Form I will complete this form, and submit it as a separate document.
- d) SRCL I will complete this form and submit it as a separate document.
- e) The Response Submission Form; What information should I put in Security Clearance Level of Bidder? What information should I put in Security Clearance Level of Bidder's Resources?
- f) SRCL Do I need to complete Section 17 of this form?

Answer:

- a) Correct, however, for M2 you must still indicate your level of proficiency in the language to which you will provide services as a Regional Media Advisor.
- b) This is not required and will be completed internally. The same information will be captured in the Form 1 Response Submission Form.
- c) Correct
- d) This is not required; the Security Requirements Checklist (SRCL) simply advises that there may be a requirement for the Respondent or the Respondents proposed resource to have a valid Reliability Security Clearance.
- e) If the Respondent or the Respondents proposed resource does not have a valid Government of Canada Security Clearance then you may indicate so. Note that during Phase 2 Request for Proposal, it will be a requirement for the Respondent or the Respondents proposed resource to have a valid security clearance.
