Question 48

For M1, the aggregate value of the compliant contracts must be at least \$1M. Please confirm whether Canada means each contract must be a minimum of \$1M or that the combination of 3 contracts be \$1 million in total.

Question 49

For M1, B indicates that each referenced contract must have a minimum of one (1) year of continuous service delivery by the Bidder to the client, however c indicates that the referenced contract must have been a minimum of 6 months in duration. Please clarify? B and C conflict. How can a contract be only 6 months yet the service delivery be more than a year. Should it be 1 year contract with a minimum 6 months of service delivery?

Question 50

FOR R3, The Bidder should demonstrate it has established project management resourcing practice, that has been in place for at least one (1) year and that will ensure the Bidder's ability to provide continued access to qualified and consistent resources for FMT in a timely manner, ensure minimal turnover of those resources, and will provided knowledge transfer and seamless transition for FMT as demonstrated through the following elements. It is unclear how a narrative explanation will be scored.

Will partial points be awarded for this Element?

We recommend providing a better guideline to the scoring;

- 5 points/element – The Element is well described and experience is clearly demonstrated
- 3 points/element – – The Element is demonstrated however lacks detail on experience
- 1 point/element – The Element lacks detail and experience is not clearly demonstrated
- 0 points/element – Detail is no clear and experience is not demonstrated

Answer 50

There will be no partial points awarded. All points allocation will be awarded on a demonstrated for full point or not demonstrated zero-point basis.

If the degree, diploma or certification was issued by an educational institution outside of Canada, the Bidder is requested to provide a copy of the results of the academic credential assessment and qualification recognition service issued by an agency or organization recognized by the Canadian Information Centre for International Credentials (CICIC). If the Bidder has not included the copy of the results in its bid, the Contracting Authority will provide an opportunity to the Bidder to submit it during the evaluation period. If the Bidder has not submitted the copy of the results within 2 working days of the request by the Contracting Authority, its bid will be rated accordingly.

Given that some international institutions have a very long processing timeframe to provide transcripts in addition to the existing processing backlog from the CICIC institutions due many of them shutting down over the summer due to COVID-19 would the Crown consider either

Providing the copy of the CICIC credential results within 60 working days of the request by the Contracting Authority OR proof, such as a file number, that demonstrates that the accreditation is in process.
