Question 6 :	kindly confirm that the IRCC will secure all accommodation sites within Lacolle region and the Greater Montreal Area
Answer 6 :	IRCC is responsible for securing all accommodation sites across Canada including those in Lacolle or Montreal.

Question 7 :	What will the layout of the food distribution be - buffet style or bagged meals?
Answer 7 :	Meals are prepared in advance by the hotel and distributed by the support services staff directly to the asylum seekers at their room (at the door of the room, on a set schedule). This may vary slightly from one site to another based on local conditions and food service offering.

Question 8 :	<p><i>" the bidder must demonstrate their understanding of the project requirement.
