Instructions:

- WCB approved hard hats and safety footwear must be worn for the site visit.
- Bidders must bring their own ladders.
- Bidders must follow Worksafe BC site inspection procedures

COVID Protocol: Masks must be brought to the site visit and are required to be worn when a distance of 2 metres cannot be maintained between people.

Contractors shall follow COVID-19 procedures in accordance with National Construction Safety Associations COVID-19 Standardized Protocols <https://www.cca-acc.com/wp-content/uploads/2020/06/CCA-COVID-19-Standardized-Protocols-for-All-Canadian-Construction-Sites-05-26-20.pdf> which was published in May 2020. Furthermore, contractors will need to address PPE and hygiene issues as per Worksafe BC regulations, and Provincial guidelines.
