This amendment 002 is raised to provide questions and answers.

Question:

We would like to go ahead with the bid. However, for the storage services we would not be able to provide storage facilities at NCR location. We can facilitate you with our Toronto warehouse. Looking at the feasibility, for us the best option is to drop the storage services option and just bid for the moving and installation services.

Can we apply for just moving/relocation and installation services? (We can provide you movers, installers, supervisors and project managers along with the requirement mentioned for trucks, vans and moving equipment.)

Please advise.

Answer:

Mandatory Criterion 4.1.1(a) Supplier's Profile, requests suppliers to provide full description of the supplier's Warehouse Facilities.

Because the scope of work is in the National Capital Region (NCR). If your arrangement does not provide requested information about Warehouse of NCR location, your supply arrangement will not be considered.
