Questions and Answers

Q1 - Can rates be offered seasonally or does it have to be a flat rate year round?

A1 – Yes the rates are seasonal. Please see Revision 1 to the Basis of Payment, above.

Q2 - Does the rate offered for the 1st year have to be maintained if the contract is extended into a 2nd and 3rd year.

A2 – No, Each optional year has separate rates.

Q3 - Basis of Selection – does this mean that only 2 hotels will be solicited to submit bids or does it mean 2 hotels will be chosen as accepted into the program.

A3 – Anyone interested may bid on this solicitation. Only 2 Standing Offers will be issued.

Q4 - Has this RFP been created to centralize the booking process for IR and Members on course.

A4 – No, this solicitation is not connected to other booking processes.

Q5 - Can I submit the RFP via my Epost Connect account for all three of my hotels or do I need to set up accounts for each hotel.

A5 – Please contact the Epost Connect group for submission details.

Q6 – Should this requirement be changed to include fully equipped kitchens, laundry and fitness facilities.

A6 – No, the requirement will not be changed.
