**Question 7:**

With reference to pre-award samples for Interlock fabric Solicitation No. 21C31-205451/A would it be acceptable to provide PAS as below:

Item 1 double interlock and item 4 Rib 1x1;

- (a) non tubular form - flat fabric
- (b) smaller and/or larger fabric width size
- (c) Alternate colour to navy blue

**Answer 7:**

Only for pre-award samples, flat or tubular fabric in alternate colors to the Royal blue with 60" width size minimum will be accepted for analysis.

**Question 8:**

With reference to pre-award samples for Interlock fabric Solicitation No. 21C31-205451/A would it be acceptable to provide PAS as below:

Item 2 and item 3 collars;

- (a) Larger or smaller than size 17" or 15"
- (b) Alternate colour to navy blue
- (c) Alternate piece weight due to size variation but of same gsm as specification.

**Answer 8:**

Only for pre-award samples, sizes must be 17" or 15" in alternate colors to the Royal blue will be accepted for analysis.

*In the event that a sample in the desired color is not available to the Offeror in a time frame to manufacture the pre-award sample, the Offeror may use a similar color, on the condition that a letter addressing the substitution is submitted with the pre-award sample, together with a statement that, should the Offeror be awarded the contract, all materials will be strictly in accordance with the technical requirements.*
