Question 1: Please confirm that in Part 4, Section 4.2.2 Price-Per Point that the maximum possible total score is 480 not 240.

Answer 1: The maximum technical score in section 4.2.2 is per resource. The total maximum score for both resources is 480 (240 x 2 resources).

Question 2: In Attachment 1 to Part 4, section 1.1.1 General information, please clarify the extent and completeness of the required description of members of the resource teams for all named projects (M-1 and M-2). Do only the roles of the 2 proposed Project Managers need to be described if they were involved? Some of the projects may involve large team sizes so a complete description of the resources may not be possible.

Answer 2: Please see the fourth point in section 1.1.1 *A description of the resource team, including their roles and responsibilities throughout the duration of the project.*

The description of the resource team should be comprised of the names of the project manager and each of the key scientific, engineering and technical staff, accompanied by two or three sentences each describing their roles and responsibilities throughout the duration of the project. Key staff can be interpreted as staff who spent a significant amount of their time (70 to 100 percent) on the project in question. The bidder may also include team members who spent less than 70 percent of their time on the project.

Question 3: In Attachment 1 to Part 4, section 2.2 Project Manager for PR-1 and PR-2 please confirm that "Managing Research and Development projects" can include management of developmental projects.

Answer 3: Yes, it can include management of developmental projects.
