Q1.) The drawings note that piles are to be designed by a specialty structural engineer. For this to be accurate we will require a geotechnical report of the area to properly design the pile foundation.

A1.) Per Section 31 61 13, Item 1.6, Contractor to carry cost for design/build of the pile foundation system.

Q2.) Please confirm the type of wood required for the project (cedar, douglas fir, rough sawn, planed smooth).

A2.) Refer to Section 06 10 00 of the Specifications, Item 2.1.

Q3.) As this is a boardwalk replacement, please provide details of the existing boardwalk, if applicable, and the extent of it.
