This Addendum forms part of, and is to be included in, the Contract Drawings and Specifications originally issued for the above-named project and no consideration will be given to any request for extras to this Contract due to the Contractor not being familiar with the Addenda. This Addendum forms part of the Bid Documents and modifies as stated herein:

1.0 SPECIFICATIONS

1.1 Section 31 61 13 – Pile Installations

Add Paragraph 1.11- Bid Basis and Changes

BID BASIS AND CHANGES

- .1 For tender purposes Contractor to base the pile design on a total length of 25-feet, including one splice per pile.
- .2 During construction the work will be valued based on the total pile length installed and total number of splices. Changes less than 10% from assumptions based on 1.11.1 will be considered at the Contractor's risk.
- .3 Contractor is responsible for all costs associated with the Load Test and all risk arising therefrom.

2.0 DRAWINGS

- 2.1 No Revision, this addendum.

3.0 QUESTIONS AND ANSWERS

- 3.1 What do the existing piles look like ? Is there an as-built drawing we can view or any information on the existing piles ??? etc, make, model, depth

The existing boardwalk appears to be founded on concrete pedestals.

- 3.2 What is the existing boardwalk lumber treated with ?

Contractor to assume the existing boardwalk lumber is not treated.

- 3.3 Will 19% Kiln Dry be acceptable?

Acceptable

- 3.4 Will the hand cap, top and toe rail be the only pieces of lumber that are S4S?

Acceptable

- 3.5 What permits (if any) are in place and what permits are required?

A building permit is required by the Contractor. Environment and Climate Change Canada is addressing the environmental permit.

- 3.6 Does the existing bird viewing platform need to be removed or replaced?

Existing bird viewing platform is to remain.

- 3.7 Is there any geotechnical information available?

No. Refer to Section 31 61 13.

- 3.8 Will GRK fasteners be ok to substitute for the handrail and the toe connections on the substrate?

Acceptable.

- 3.9 Several similar questions were received with regard to bidding for the piles and how to address risk. These include:

3.9.1 What length are the piles going in ? and what length are the piles coming out?

3.9.2 Will there be provisions for extra piling extensions required if certain areas are extremely deeper than others?

3.9.3 What is the expected depth that the piles would go to in order to satisfy the requirement?

3.9.4 If the Contractor proposes changes to the pile design based upon the results of the load test will a Change Order be issued to cover extra costs for re-design, installation of larger piles or additional piles? Please confirm who will be responsible for the cost risk of unforeseen ground conditions.

3.9.5 Is the owner able to provide anticipated pile depths to insure that bidders are pricing the same scope of work? I understand that there is an unknown without a Geotech report but a starting point would lead to less risk needing to be accounted for in pricing.

Refer to specification revision, this addendum, to address these items.
