A2. Structural capacity is unknown, wharf decks are rated light duty, slip/ramp available for launching equipment.

Q3. Will there be space on shore made available for contractor use? Ie. storage of discharge pipeline, site trailer, etc

A3. Yes service area by main highway

Q4. Will the Contractor be provided berthage space at the wharf for its use? This may included regular berthage of a workboat and berthage of the dredge during storm events.
