

THE PURPOSE OF THIS AMENDMENT IS TO GIVE EFFECT TO THE FOLLOWING CHANGE;

1. Section "SI 1.1 Submission of Bids" is deleted and replaced by:

SI 1.1 Submission of Bids

Bids must be submitted only to Parks Canada Agency Bid Receiving Unit by the date and time indicated on page 1 of the bid solicitation. Bids submitted by mail, in-person or by courier may not be accepted.

The only acceptable email address for responses to bid solicitations is <u>pc.soumissionsest-bidseast.pc@canada.ca</u>. Bids submitted by email directly to the Contracting Authority or to any email address other than <u>pc.soumissionsest-bidseast.pc@canada.ca</u> will not be accepted.

The maximum email file size that Parks Canada is capable of receiving is **15 megabytes**. The Bidder is responsible for any failure attributable to the transmission or receipt of the emailed bid due to file size.

The Bidder should be cognisant of the size of the email as a whole, and not only the attachments. Please take into consideration that some attachments, when sent, may be resized during the email transfer. If the email size is too large, the Bidder should send the bid in multiple emails properly labeled with the solicitation number, project name, and indicate how many emails are included (ex. 1 of 2).

Emails with links to bid documents will not be accepted. Bid documents must be sent as email attachments.

2. Questions, Answers, Clarifications:

1. Will the existing CAD drawings be made available to the successful bidder?

3. Is there any requirements for exterior upgrades, such as sidewalks or site drainage?

Answer: No. There are no requirements for exterior upgrades. There are no sidewalks. There are no requirements for site drainage

4. Can it be assumed that a Building Permit from Government of Nunavut is required?

Answer: It will be the responsibility of the Contractor to acquire the necessary building permits with the Government of Nunavut or the Hamlet of Resolute Bay.

5. Will there be a need to specify specific requirements regarding the disposal of construction waste?

Answer: The consultant will need to be familiar with the requirements to bring material to the hamlet's dump or to ship material of site as needed. The contractor will be responsible to seek authorization from the hamlet to place material into the hamlet's dump for disposal of construction material or to package the material up in accordance with the shipping requirements.
