Q1. If we do not receive a response from Prophet River, we cannot have the IBP certification signed. How do we ensure our bid validity?

A1. *If you do not receive a response from the designated representative of the Prophet River First Nation within 5 calendar days of the tender closing date, you **must still submit**:*

-Completed IBP form – What you were planning to propose to the Prophet River First Nation

*-IBP certification **signed by the bidder only***

-Email proof that you had tried to contact the representative of the Prophet River First Nation

Note, this is just the IBP portion of the submittals. To ensure bid validity, you also have to submit the other bid documents as outlined in the tender documents.

Q2. To ensure our bid is compliant, do we still need to dedicate 15% of the value to Prophet River contributions even if we have no commitment or expression of interest from the Nation?
