Question 18

When we read the Note Box above, we understand that we need SIN number in order to proceed.

However, we do not have an SIN Number at all, being a non-resident entity.

Based on what it says in the Note Box above, we can not register online as we do not have an SIN Number that starts with a number other than 9

We are not supposed to contact the TSO Offices listed, in our case Fraser Valley and Northern, because we do not have an SIN starting with 9

As such, system does not allow us to proceed further with lack of SIN.

Please advise.

Response 18

A Social Insurance number (SIM) is not required to register for a Procurement Business Number (PBN).

If you wish to do business with the Government of Canada; You must first register your business with the Canada Revenue Agency (CRA) to obtain a NON RESIDENT Business Number (BN).

Non-residents

You may be carrying on business in Canada even if you do not have a [permanent establishment](#) in Canada.

Non-residents wanting to register for GST/HST must complete [Form RC1, Request for a Business Number](#), and fax or mail their application to the Non-Resident tax services office below:

Then once you have received your BN from CRA, you can then register your business in the Supplier Registration Information (SRI) system by accessing the buyandsell.gc.ca "Register as a supplier" page.

Please remember to follow all the steps and to enter the required information: your Business Number (BN), (or GST number); the Legal Name of your business (**Important:** The legal business name must be entered in the exact same as you registered in the BN system of CRA). Next you will be required to complete your profile; address and contact information. During your registration in SRI, take the time to identify all goods or services in the (commodity section) that you can supply.

Note: Contracting officers often search for potential suppliers by description or commodity code. It is therefore important to list what you sell to make yourself visible to government buyers.

In addition to your registration in SRI, we advise you that it is important to look and submit tender opportunities of interest to you on www.buyandsell.gc.ca/tenders

You can search by word or you can use the same GSIN codes (commodities) that you entered in the SRI and PBN account.
