Evaluation Criteria and Basis of Selection

RFP: Professional Validation Services for GMP Biomanufacturing Facility

Bid Evaluation Process: The proposal will be evaluated and scored in accordance with the specific criteria as detailed herein. It is imperative that these criteria be addressed in sufficient depth in the proposal to fully describe the bidder's response. The evaluation will be conducted by LOTs as identified in **Appendix F - Equipment List & Utility System Qualification.** Each LOT will be ranked according to the Rated Requirements as presented in Table 2. NRC reserves the right to award each LOT separately to different vendors or group 1 LOT or more and assess the LOTs in groups, at its sole discretion, to select the most beneficial combination of LOTs, according to its needs. NRC may also assess all the LOTs as one group for evaluation purposes and award to one single vendor, at its sole discretion.

Basis of Selection: Highest combined technical score (70%) and price (30%) with a minimum consensus score of 70%.

To be declared responsive, a bid must:

- (a) comply with all the requirements of the bid solicitation.
- (b) meet the mandatory evaluation criteria;
- obtain the required minimum consensus score of 70% of the points for the technical evaluation criteria (*Rated Requirements*); and

Bids not meeting (a) or (b) or (c) will be declared non-responsive. Neither the responsive bid obtaining the highest number of points nor the one with the lowest evaluated price will necessarily be accepted.

The responsive bid(s) with the highest combined technical score (70%) and price (30%) according to the evaluation process as described above will be recommended for award of a contract (s).

NRC may accept minor non-compliances at its sole discretion. Minor non-compliances may be defined according to NRC's own interpretation only.

Mandatory Requirements

Proposals must address the mandatory requirement described below. This will be evaluated as either "Yes" or "No". Failure by bidders to meet the mandatory requirement will render the bidder's proposal non-responsive and it will not be considered further.

Proposals should clearly identify the firm's ability to meet the mandatory requirement (e.g., provide relevant proposal page numbers against the mandatory requirement). NRC reserves the right to seek further validation of any mandatory compliances.

1.3 Financial Requirements

Financial proposal must be submitted using **Appendix C Pricing Form**.

Bidders must submit their financial bid in Canadian funds and in accordance with the pricing form provided. The Bidder must complete this pricing schedule and include it as a separate attachment in the electronic bid submission and clearly identified as **Pricing Proposal** as indicated in section 7.0 of the main RFP document.

The Bidder's all-inclusive per diem rates in response to the RFP and resulting contract will apply to where the Work is to be performed in Canada as may be specified in the RFP and the resulting contract.

All-inclusive per diem rates and other expenses included in the pricing must include the total estimated cost of all additional expenses need to be incurred for Work described in the Statement of Work.
