1. Question 1

I was wondering if it is possible to know the break down on shingle roof systems and flat roofs? In the ABES. PROD.PW_FK.B317.E79356EBSU000 it states that there are 637 total residential units in Shilo MB, but does not state of any flat roof systems.

The RFSO speaks in regards to flat roof systems as well. Will work be performed on any other crown owned/CFHA managed buildings in Shilo?

Answer 1

All Residential Housing Unit roofs at Shilo are sloped and shingled.

Question 2

The priority 1 response time is 1 hour; however we are located in Winnipeg, which is over this time frame. The information below does state that that the CFHA may adjust the time frame. Does this apply to the EAHRS calls as well?

4.2.3 If, after receiving a Call-up, the Contractor finds reason or cause that would preclude him from meeting the prescribed time frame(s), he shall immediately advise the CFHA representative. CFHA representative may then adjust the time frame(s) or, at their sole discretion, re-assign the Call-up.

Answer 2

Priority 1 also applies to after-hours service calls (EAHRS). The personnel on duty will contact the Contractor to explain the situation and it is expected that the Contractor must be present on site within the prescribed time limits. During an emergency call, the contractor is required to render the situation safe make the premises safe and not to carry out all the required repairs in full.

Priority 1 is also applicable to Emergency After Hours Service (EAHRS). The Duty Officer will contact the Contractor to explain the situation and it is expected that the Contractor must meet the priority 1 one hour the time frame.

2. DELETE 8.6.3 Other Direct Expenses – Hot Work Permit Fees in its entirety and replace with:

8.6.3 Other Direct Expenses –Permit Fees

The Contractor will be reimbursed for the direct expenses reasonably and properly incurred in the performance of the Work as described in Section 13.2.1.4 of the Annex A Statement Of Work and in Part 1, Section Permits, Fees and Inspections, of Appendices 6.2; 6.5; 6.9 and 6.13 Schedule of Unit Rates Specification. These expenses will be paid at actual cost without mark-up, upon submission of an itemized statement supported by receipt vouchers

3. DELETE 8.6.7 Methods of Payment in its entirety and replace with:

8.6.7 Methods of Payment

8.6.7.1 Single Payment

Canada will pay the Contractor upon completion and delivery of the Work in accordance with the payment provisions of the Contract if:

- a. an accurate and complete invoice and any other documents required by the Contract have been submitted in accordance with the invoicing instructions provided in the Contract;
- b. all such documents have been verified by Canada;
- c. the Work delivered has been accepted by Canada
