1. Provide clarification and answers to questions from potential suppliers.

Questions and Answers:

Question 5	<i>The lowest height requested is 740 mm to match the loading ramp of a C130, but the ramp minimum height is 952mm. Why the requirement is 740 mm? Where did this value come from?</i>
Answer 5	Refer to answer to question 2.
Question 6	<i>In the document at 3.4.1 a) the required is 25 km/h (15.5) but at page the 40 in the Technical Mandatory Criteria matrix table 3.4.1, is written 25km/h (40 Mph). We assume the real request is 25km/h and it's just a typo in the matrix.</i>
Answer 6	Refer to answer to question 3.
Question 7	<i>Does the unit need some parking brakes? The only stated thing is the surge brake system.</i>
Answer 7	The trailer requires surge brakes and wheels chocks. Refer to Purchase Description 3.14 a) and art. 3.21 b).
Question 8	<i>Are they using pallet train on this type of unit?</i>
Answer 8	Pallet model 463L are used.
Question 9	<i>The only question we have is are there any details on the tow vehicle further to what has been shared? There is mention of a drawbar but we are not clear if the towing vehicle has a pintle hitch or a conventional fifth wheel connection? If you can advise so we can supply a solution that fits with the standard towing vehicle used at the delivery locations we would appreciate it.</i>
Answer 9	Refer to Purchase Description art. 3.20 a) to 3.20 e).
