## AMENDMENT 001

This amendment 001 is raised for the following:

- 1) Respond to questions received during the period of solicitation.
  - 2) Modify the tender - see changes in [blue](#)
- 

**Q1.** Concerning Category 1b, Lines #5 & 6, would the end-user consider a range between 8"-12" while still not exceeding the maximum height of 54"h?

**A1.** Yes

**Q2.** For the NSA products: Privacy Panel - Frosted glass. Is frosted acrylic acceptable?

**A2.** Yes

**Q3.** For the NSA products: Personal tower, 4 unit multiple locker set, 2 unit multiple locker set: Painted metal frame and laminate door. Is a construction of laminate frame and door acceptable?

**A3.** No

**Q4.** CAT6B item 4. The code refers to a polypropylene backrest but there is a contradiction in the description with the mention "mesh backrest". The SA does not call for upholstered options on the back so there is no provision for mesh backs. It also states perforated backs are not allowed. Can we supply a poly back or treat this as Non-SA?

**A4.** A unperforated polypropylene or mesh backrest is specified in additional notes, therefore accepted.

**Q5.** Category 1b – Item 3-4 - Where are these components in the plan? In order to ensure that the right components are proposed.

**A5.** These items are now removed from the call for tenders. You do not have to take them into account.

**Q6.** Category 2 – Item 12 - Where are these components in the plan? In order to ensure that the right components are proposed.

**A6.** This item is now removed from the call for tenders. You do not have to take them into account.

**Q7.** Category 1b – Item 2 - A centered grommet is required, but the centered grommet will conflict with the bracket attached to the center panel. Is it correct if there are 2 grommets?



**A7.** Please note that we require a double monitor arm to be installed in a central grommet in the work surface. If we accept these types of grommets, we will have to drill the surface in the center to integrate the double monitor arm = so make sure there are no possible conflicts with any other components.

**Q8a.** Category 6 Chairs – Item 3 - Is a 4 foot base accepted (same model as item #4)?

**A8a.** No

**Q8b.** With upholstered seat as requested:



**A8b.** However, this type of upholstered seat is accepted.

**Q9.** NSA – Items 19 to 21 - Please give more details on the need for the rail and compartment in the door. What is the purpose of the compartment? Is the track necessary if the compartment can be attached directly to the door?

**A9.** See specific notes: compartment of +/- 12"W x 8"H (one briefcase).

If the door does not have a rail to accommodate compartments, the door must be equipped with different pre-set or integrated adjustments and/or positions, so that we have the possibility and latitude to adjust the compartment to the desired location in the door (an adjustment range of 20"H in the door).

This should also allow us to add compartments/accessories to the door in the near future.

REQUIREMENT and BASIS OF PAYMENT**

1. Category Selection

**Combined Categories Rule:**

For reasons of compatibility, the following categories will be combined for evaluation and contract award purposes:

The rule only applies to the categories below that are checked. The unchecked categories will be evaluated separately and may be awarded to multiple suppliers;

Category 1

**\* Exception: when using the Cat 1, 2, 5 combined categories rule, IU's may calculate the percentage of NSA product allowed (as defined in their solicitation document) against the total quantity of the combined categories.**

**Design Upgrade Rule:**

The IU may exercise an option to upgrade products up to 20% of each Category product total before Applicable Taxes after contract award.

The Design Upgrade amount is used at the discretion of the Project Authority (PA) **prior to the manufacturing/ordering of the products**, the PA will provide the Contractor with a written notice of Canada's Design Upgrade choices for each of the product(s) to be upgraded. The Contractor will provide the pricing of the upgraded product(s) to a maximum of 20% of each Category Contract Price of Table 8. The Contracting Authority will issue an amendment to the contract with the Design Upgrades and pricing.

The Supplier certifies that all the Design Upgraded products offered will conform to all specifications and meet the testing requirements detailed in the Specifications of the Supply Arrangement.

Design Upgrade: is the process of replacing a product with a more innovative or enhanced version of the same product.

**NSA:**

NSA products can be incorporated in the RFB and must not exceed 30% of the firm quantity by category. NSA items must be added to the category that is most closely related and must be generic.

The requirement includes the following category (ies) of work:

a. Category 1 – Interconnecting Panels and Freestanding Systems

Category 1a – Interconnecting Panels (Refer to Annex C)

Category 1b – Supporting components and freestanding furniture

**RULE:** Metal Storage

Identified Users may procure metal storage products forming part of Category 1 when the metal storage products will be part of a requirement for a workstation(s)/work point(s). If this rule does not apply, Category 3 must be used for the metal storage products forming part of this category.

b.  Category 2 – Freestanding Height Adjustable Desk / Table Products

c.  Category 3 – Metal Filing and Storage Cabinets

Identifying the maximum height of the Personal Storage Towers, Wardrobes and Storage Cabinets is acceptable as per 6B. 4.1 of the SA (table 1 Additional product details)

d.  Category 4 – Wood Veneer – Freestanding Products

e.  Category 5 – Ancillary and Lighting Products

f.  Category 6 - Support Space – Collaborative Furniture

**RULE:** Category 6 can be further subdivided by space or like product in order to increase or allow competition. Space is defined as a location available for a particular purpose such as a meeting room space or a collaborative space. Like products are defined as products with similar design and construction. If NSA products form part of the requirement, the IU must validate the 30% NSA prior to subdividing the category. NSA products can be added to any subdivide or in its own subdivide.

The IU must identify how Category 6 will be subdivided in the Product Table for Category 6.


