Title: Digital Recruitment Reach Solutions

This amendment was posted to answer questions from Industry.

Q1: How do the objectives of this RFI differ from the previous RFI and canceled RFP (D1124-190034)?

A1: This RFI is for digital recruitment “Reach” solutions only, such as professional networking and job matching platforms. These are platforms through which we would promote jobs that are advertised on the Government of Canada recruitment system more widely. It is different from the RFI No. D11124-190034, which was for a recruitment solution with applicant tracking and candidate management capabilities.

Q2: Much time and effort have been spent on previous responses related to this RFI. In order to be fair and transparent to vendors can PSC please provide a timeline with distinct milestones to show when contract will be awarded?

A2: This is the first time that the Public Service Commission is posting an RFI related to “Reach” solutions. Based on the information that we gather through the RFI, a RFP may be issued for Proof of Concept testing. We anticipate issuing an RFP as early as April 2021 and a contract for Proof of Concept around July 2021.

Q3: Will the PSC be piloting this recruitment solution as they did with the NEXTGEN Payroll RFI? If so, will this be a GoC funded exercise?

A3: No. This RFI is a separate initiative led by the Public Service Commission.

Q4: Will the selection of SAP for the NEXTGEN Payroll solution factor into the decision for this RFI?

A4: No. This RFI is a separate initiative led by the Public Service Commission.
