Amendment 3 is raised to publish questions and answers:

Q3. Regarding the bid mentioned in the subject line we would like to ask if the end user will accept regular rectangular tops (with no scoops) for the height adjustable tables or do they require them with grommets?

A3. According to our specs in the Supply Arrangement, at section 2.2 General Features, at 2.2.23 Wire Management, sub item 3 states:

.3 All work surfaces measuring 1219mm (48 in.) in width and less must have one (1) grommet or one (1) finished gap as part of the work surface. All work surfaces greater than and including 1372mm (54 in.) in length must be provided with a minimum of two (2) grommets or two (2) finished gaps incorporated into the work surfaces

Height adjustable surfaces must have either a grommet or a finished gap as part of the work surface. Surfaces without either will not be accepted.

Q4. I reviewed the amendment this morning and I would like to clarify my question.

I understand that the GoCUID is valid, however, I would like to request that we separate CAT5 power modules and CAT 2 instead of having them combined, the reason is that these clamp modules can be used on any manufacturers tables and are not integral to the operation of the table. We respectfully request that this be separated out so others can bid and provide better pricing to Canada.

A4. No. This solicitation will remain unchanged. CAT5 and CAT2 will remain combined. Please bid as per the solicitation.

Q5. In regards to the above mention solicitation, can you confirm that the product going to 405 Terminal Ave is to only be brought into the loading dock area? It will be kept there until needed for the phased in delivery.

A5. The product going to 405 Terminal Road will need to be delivered from the delivery truck to the respective floor based on the phase of delivery. There is a freight elevator that will be made available for delivery.

Q6. In A1 you say the product is to be placed into storage at 150 Chardon Driveway. Can you explain where this storage space is? How far from the loading dock doors and are there any elevators.

A6. The address is a 1-story building. The delivery truck can pull up to the garage door on grade, which opens into an open space. There is no racking in the space. How product is arranged/stored in the space is dependent on how the manufacturer packages product for delivery. There are no elevators in the space.

Q7. Our company will be closed for the Holiday season from December 21st, 2020 until January 5th, 2021 inclusive. Will you please grant an extension and move the closing date after January 5th, 2021 so we can submit a bid?

A7. No, an extension will not be granted for this solicitation. Phase 1 product must be delivered no later than March 31st 2021.
