AMENDMENT 003

This amendment 003 is raised for the following:

Q12. In lines 5-6, the correct quantities according to the plan are 15 (instead of 16) and 42 (instead of 41). Same for the A42x30 and A42x36 panels. The quantity of A42x30 is 15 (instead of 16) and the quantity of the A42x36 is 42 (instead of 41).

We believe that the error may be at the workstation 19, where there is a 36in panel instead of a 30in panel like everywhere else on the side of the adjustable table.

A12. The quantities of panels indicated in the plan represent the right quantities required. However, a correction has been made in the Panel Matrix to change the quantities of the panel B42x30 not electrified to 15 (instead of 16) and B42x36 not electrified to 26 (instead of 25).

AND, in the call for tenders:

The quantity of item 5 must be 15 (instead of 16)

The quantity of item 6 must be 42 (instead of 41).

ALL OTHER TERMS AND CONDITIONS REMAIN THE SAME.

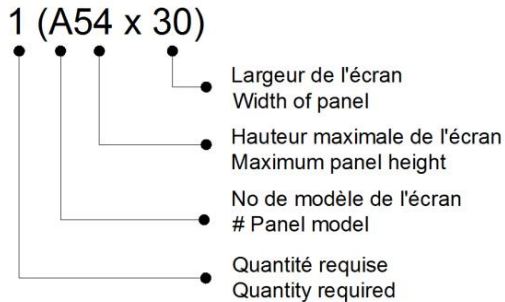
