This amendment is raised to answer questions from potential respondents.

QUESTION 1:

Can a Canadian company respond and be eligible to bid as prime with a foreign partner Original Equipment Manufacturer (OEM), using the partner's experience, given an authorization from the OEM?

Answer:

Please note that the eventual Request for Supply Arrangement (RFSA) may not be subject to Canadian Content but the Request for Proposals issued against the Supply Arrangement likely will be.

QUESTION 2:

Can an American company respond and be eligible to bid, as long as they have a Canadian partner that can help them fulfil the Canadian content requirement?

Answer:

See answer to Question 1.

QUESTION 3:

The RFI document has Annex B, which is the draft RFSA. Do we need to do anything as of now in order to start the process to setup a supply arrangement or will this process only take place once the RFSA is separately issued?

Answer:

Yes, that is correct. Annex B is only a Draft RFSA. Respondents are NOT required to provide a bid at this time. We plan to publish the official RFSA on Buy and Sell in the Spring of 2021.

All other terms and conditions remain unchanged.
