#### 2. Questions and Answers:

# Question 1:

I saw that the schedule was removed so basically an on call for all services. So I am hoping we just put in a per service cost and Corcan services as an on call for even the front load bins. I have never priced a 12 yard front lift so I was also wondering if you mean a 12 yard roll off or lugger box service?

## Answer 1:

See the revised APPENDIXB1 – Basis of Payment <u>Revision1</u>, attached separately. **For STREAM 4** - the 12 yard container can be a roll-off or a lugger box. **For STREAMS 1, 2, 3, 5 and 6** – the 12 yard front-end container has been removed. Note as well that

some other container sizes have been removed from the STREAMS.

# Question 2:

In reading your tender it does state all waste is basically construction material other than the Warehouse in Kingston which can be normal warehouse waste. So If I read this right, the 4,6 and 8 yard bins are for construction waste as well?. Also would they all be temporary bins so delivery and removals, or would they be permanent bins on site. Just want to make sure I have this priced accurately for what you are requiring.

#### Answer 2:

The 4, 6 and 8 yard containers are for Construction and Manufacturing waste depending on the institution, please refer to ANNEXA – Statement of Work 1.2 Objectives <u>and</u> 1.3 Tasks. As for the question regarding temporary or permanent options for the containers, please refer to ANNEX A – Statement of Work 1.4 Schedule.
