QUESTIONS AND ANSWERS

Q1. Can we establish a Minimum order quantity?

A2. There is no minimum order quantity

Q2. What will be a typical order quantity for the various locations?

A2. For orders made by Divisional Stores, it could range from a few dozen to a few hundred. For orders made by individual Detachments, it is more likely in the range of a few dozen per order.

Q3. Does the kit have to be identical to Annex E?

a. Can we offer a kit that contains the same information but using a different layout?

b. Does every element have to be identical to Annex E or can it be a substitute?

A3. Yes. Kit must be identical to Annex D Purchase Description.

Q4. Section 3.1 allows for email submission, what address must the submission be sent to?

a. Section 2.2 indicates that the RCMP has not approved for bid submission by epost Connect service, how does this impact the submission process?

A4. As per section 4.1.1, The RCMP will only request samples from up to the three lowest priced Offerors. The location will be specified at the time of request. Also note that RCMP is not approved for bid submission through epost Connect. Please submit bids only to email on page 1 of the solicitation document.

Q5. Section 2.8: indicates the primary receptacle made of clear plastic, cardboard or fibreboard must be included as part of the kit. Can the primary receptacle be made of a different material? Is Styrofoam, which provides better safety, accepted?

A5) No. The specifics from the Purchase Description must be followed.

Q6) Section 2.8: indicates the primary receptacle must be sealed with tamper evident seal prior to use. Can the primary receptacle be seal in the secondary receptacle and then the whole kit be sealed in a heat seal plastic sleeve instead?

A6) No. The specifics from the Purchase Description must be followed.

Q7. Does the RCMP suggest recommended carriers to service remote locations since most commercial carriers do not provide regular service to remote locations?

A7) We do not have any recommendations on carriers or delivery agencies relating to transportation.
