QUESTION 1:

ANSWER 1:

If so, please identify the means by which such services have been supplied and under what work stream (e.g., direct and or term employee, personal services contract, or contracted services through a company). If the services were contracted through a company, please provide the name of the Contractor, and the duration and dollar amount of the contract(s).

ANSWER 2:

This is a standalone solicitation which will result in contracts defined in the requirement of this solicitation, with an estimated award date of April 1st, 2021. QUESTION 3:

Workstream 1 – Real Property Project Management Services: Given the scale of the effort required, 178,500 hours according to the estimated level of effort in the pricing schedule, can you consider fragmenting the program to several suppliers according to a ranking system based on a rotation of qualified firms (minimum of three), all in order to promote fair competition within the project management industry.

ANSWER 3:

The Request for Proposal is divided into four (4) workstreams and each workstream will result in one (1) contract; therefore the RFP will award four (4) contracts.

QUESTION 4:

Considering the holiday season and the pandemic situation (red zone in major centres), we would require an extension of the deadline for the closing of this solicitation to mid-February?

ANSWER 4:

Canada's intention is not to extend the bid solicitation. The bid closing date will remain January 25, 2021.
