1. QUESTIONS AND ANSWERS

Q14) Log Analytic solutions and APM solutions have a lot of overlapping functions. Is CRA considering replacing its existing APM platform?

A14) No.

Q15) Can CRA let us know what the current APM platform/solution is, and further elaborate on whether the Log Analytics solution must interact with the current APM?

A15) There is no requirement for interoperability between Application Performance Monitoring (APM) and Log Analytics software.

Q16) Would CRA accept an attestation letter that the solutions user interface will include both English and French in a future release for M1?

A16) No.

Q17) Please remove from M26 the sentence that states: "After the Administrator defined time period of inactivity, the software must destroy the new session keys, master secret key, and the new server random and client random values on both the server and the internal CRA computing client."

A17) See revised mandatory requirement M26 under RFP Amendment #03.

Q18) We are requesting an extension of the submission deadline to January 25th.

A18) The RFP closing time has been extended under RFP Amendment #03.
