### REVISION 003

This revision is to publish questions and answers as follows:

**Q1. In this unique period of a global pandemic, which is shaking up all economies, we are facing a major pitfall. The cost of raw materials fluctuates in an unpredictable way as never seen before. The supply of certain commodities is becoming complex and the scarcity of certain materials due to the pandemic makes negotiation complex.**

**It is therefore virtually impossible for us to predict the costs for the next 4 years, as one would have been able in a normal economy. As a supplier we therefore have no choice but to protect ourselves by adding a significant % protection in our proposal, which translates into a price increase for the government which may not be necessary.**

**In this context, we would like to offer you a solution that shares the risks between the government and us. We offer you a price adjustment clause based on market prices, documented by public indexes or letters from suppliers, which would allow the prices of items to be lowered or raised depending on the market, twice a year.**

**A1:** We cannot accept your proposal. We invite you to submit an offer in accordance with the terms and conditions set out in the Request for Standing Offers (RFSO) E60HS-20PACK/A which closes on January 8, 2021 at 14:00 Eastern Standard Time (EST).

As specified in the RFSO, this requirement is for an initial period of two (2) years from the effective date of the Standing Offer, with an option to extend the offer by one (1) additional period of one (1) year.

**Q2. How many bags per roll are included for items 1111, 1112, 1113 and 1114?**

**A2:** The number of bags per roll is detailed as follows:
