The purpose of Amendment number 013 is to answer a bidder's question.

QUESTION AND ANSWER

Question 64

Quebec announced on December 15th that they were shutting down all non-essential services until January 11, 2021 in order to get the escalating coronavirus cases under control. On December 26th Ontario went on a province-wide shut down until January 23rd, 2021. While the various Government organizations along with the private sector organizations we require these letters from are primarily considered essential services, many of our key contacts have elementary level children whose schools are shut until January 11th. As a result we are having difficulty contacting some clients who are supporting their children and families during these uncertain times until their young students head back to school.

While we understand that PWGSC/PSPC has many mandates that will be affected by the contracts to be awarded through this procurement process and therefore it is tough to consider any further extensions to the proposal process. However, we are still respectfully requesting that the Crown grant an extension to January 18th (one week after the Quebec Government's mandated shutdown and Ontario Elementary schools reopen) in order to allow vendors the time needed to contact their key clients for the signed/email certified attestations?

Answer 64

Canada has reviewed the request, however the closing date of this Solicitation remains unchanged.
