Amendment number 004 is raised to answer supplier questions and extend the closing date:

- Q6:** In reference to the RFSO, if we are awarded a standing offer for a certain destination, is it possible to withdraw from one of the other locations without any negative effects on our company?
- A6:** Each requirement is awarded on an item-by-item basis (except for the grouped requirements indicated at Part 3, Section I, Technical Offer – A.1. Grouped Requirements). Withdrawal from a requirement will not impact the other requirements in your standing offer, unless it is a grouped requirement.
- Q7:** Would DND allow Jet A-1 with FSII only as an acceptable product (for F34 requirements)?
- A7:** Jet A-1 with FSII only is considered an alternate product as described at Part 3, Section I, Technical Offer - C. Alternate Products.
- Q8:** Is Jet A-1 an equally acceptable product to Jet B?
- A8:** No, Jet A-1 is not an equally acceptable product.
- Q9:** The government usually gives 90 days' notice on SO requests, have this policy change to 30 days?
- A9:** No, the policy has not changed. The international trade agreements require solicitations to be posted a minimum of 40 days, this solicitation has been posted for at least 40 days.
- Q10:** We kindly request for a one week due date extension until January 19th.
- A10:** The closing date has been extended to January 19, 2021.

- DELETE:** 2021-01-12
- INSERT:** 2021-01-19
