Solicitation Amendment 001 is being raised to answer bidder questions and amend the Solicitation document, as follows:

Questions and Answers:

Question 1: Paragraph 3.1(ii) of the Solicitation document states that the maximum number of pages per project is two (2) whereas paragraph R2(ii) of Attachment 1 states that the maximum number of pages per project is one (1). Please confirm the maximum number of pages allowed per project (4 projects in total).

Answer 1: The maximum number of pages allowed per project is two (2). Paragraph R2(ii) of Attachment 1 has been amended to reflect the clarification. Please refer to amended paragraph R2(ii) below.

Question 2: Please clarify the breakdown of item R3(II)(b), "Identify the personnel's years of experience, the number of years with the firm (50 Points)." Are the years of experience and years with the firm weighted equally or is one weighted higher than the other?

Answer 2: The years of experience and years with the firm are weighted equally.

Question 3: Is there a local Atlantic Province weighting for the personnel and/or projects?

Answer 3: There is no weighting assigned to geographical location.
