- 2) To ensure consistency and quality of the information provided to Bidders, the Contracting Officer shall examine the content of the enquiry and shall decide whether or not to issue an amendment.

SI03 OPTIONAL SITE VISIT

It is recommended that the Bidder or a representative of the Bidder visit the work site. Arrangements have been made for the site visit to be held on **Thursday**, **January 14**th, **2021 at 10:00 a.m.**, **MST.** Interested vendors are to meet in the front lobby of **Police Dog Service Training Centre (PDSTC) located Exit 365 East, Highway 2, Innisfail, AB.**

Only two (2) attendees from each bidder will be allowed to attend the site visit, this includes any of the subs they are requesting to attend, due to the current COVID-19 restrictions. Bidders must notify the Contracting Authority, via email, two (2) days prior to the scheduled visit to confirm attendance and provide the name(s) of the person(s) who will attend, if no notification is provided the site visit will be cancelled. Bidders who do not participate in the visit will not be precluded from submitting a bid. Any clarifications or changes to the bid solicitation resulting from the site visit will be included as an amendment to the bid solicitation.

In response to the events surrounding the COVID-19 pandemic, bidders and/or their representatives are requested to follow all the Government of Canada recommendations in relation with <u>preparedness</u>, <u>symptoms</u>, <u>treatment</u>, <u>prevention and risk</u>. - 1. The following security requirements (SRCL and related clauses) apply and form part of the Contract. Before the commencement of Work the following conditions must be met:
 - 1.1 The Contractor's personnel are required to be security cleared at the level of Facility Access with escort as verified by the Personnel Security Unit (PSU) of the Royal Canadian Mounted Police (RCMP).
