1. Update Annex F0 – Compliance Evaluation Matrix; and
2. Provide answers to Industry's questions.

Answers to Industry's questions :

1	Due to Covid-19, it has been difficult to obtain support from suppliers for integration of their products into a TACS solution. This has been especially true for items under ITAR control. These items primarily affect the RAP requirements. We request that when demonstrating a requirement associated with the RAP during the Bid Demonstration, a bidder be assigned full points ("Operational") for these requirements regardless of whether the software associated with these requirements has been fully-developed and integrated into the final proposed TACS software solution. Please advise if this request can be accommodated for the Bid Demonstration.	Assignment of full points ("Operational") for these requirements regardless of whether the software associated with these requirements has been fully-developed and integrated into the final proposed TACS software solution would defeat the purpose of evaluating software readiness for which the points being awarded. Since these requirements and associated circumstances are not unique to one bidder the demonstration requirements will not be amended.
2	Considering many suppliers and subcontractors close down over the holiday season and there are still requests for clarification which remain to be addressed by the Crown that could impact a bid response, we hereby request an extension to the current solicitation closure date to February 28, 2021	Considering that this RFP has been posted since 4th of September with multiple extensions and the fact that the latest amendments has not changed the fundamental aspects of the RFP, Canada will not be considering any further extensions
3	Reference RFP Amendment 9, page 2/8, Section 4.1.1.4 paragraph 2: "Evaluate each bidder's response to technical rated criteria, as populated in Annex F0 – Compliance and Evaluation Matrix, Demonstration-Scoring Matrix." • Can the Crown please specify the evidence a bidder is required to submit in their bid response to prove compliance to the technical rated criteria, as populated in Annex F0 –Compliance and Evaluation Matrix, Demonstration-Scoring Matrix.	ONLY APPLICABLE TO: RFP Amendment 9, page 2/8, Section 4.1.1.4 paragraph 2. The bidders must provide at least one of the following evidence categories as the proof of readiness for technical demonstration requirements: 1. Product certification (by a recognized/governmental organization in the domain), approval or referencing letter from well-known clients (national defense organizations) that demonstrates that the proposed solution complies with the stated requirement. 2. Product specifications, NSN numbers, manuals, technical brochures, test reports or any other documentation that demonstrates that the proposed solution complies with the stated readiness level.

This information is sought to ensure that we have appropriate licenses/agreements in place to facilitate the demo e.g. Technical Assistance Agreements (TAA). For example, if PSPC must attend the demonstration, and they are not already a party to a Technical Assistance Agreement (TAA), it would take 60 to 90 days to obtain U.S. Department of State approval to add PSPC as a party.
