**INSERT the following at the end of the clause:**

The Contractor must perform the Work in accordance with the Statement of Work in Annex A.

The Contractor grants to Canada the irrevocable option to acquire the services referred to in section RS 1 General Services (Workstream 1) 1.2.1; 1.2.2; 1.2.3, 1.2.5, 1.2.6, 1.2.7, and 1.2.8 / (Workstream 2) 1.2.12, 1.2.13, and 1.2.15 / (Workstream 3) 1.2.16, 1.2.17, 1.2.18, and 1.2.19 / (Workstream 4) 1.2.23 and 1.2.24 of the Statement of Work in Annex A of the Contract under the same conditions and at the prices and/or rates stated in the Contract. The option may only be exercised by the Contracting Authority and will be evidenced, for administrative purposes only, through a contract amendment.

The Contracting Authority may exercise the option at any time before the expiry of the Contract by sending a written notice to the Contractor.
