Does the CASSAR system require an operator display? If yes, please detail the display requirements for system and detected information to be available to the operator. Please detail the GIS requirements within the display to consider 3 dimensional terrain and line-of-sight considerations. If no, please detail the requirements to interface to the aircraft display systems."

An operator display will be required as part of the CASSAR system as per Annex A, Statement of Work, section 1.6 which states: "A CASSAR system is defined as all of the hardware (ex: LRU, protective case, antennas, cabling, computer, etc) that is required for full operation of the CASSAR."

The CASSAR system provided must include any required operator display (through laptop computer or other means) and must not require interface with the aircraft display system. The operator interface and display must allow for use of all the CASSAR system functionalities, as required in the Statement of Work and allow the operator to properly convey accurate geo-location information provided by the CASSAR to the other crew members.

The following sections in Annex A, Appendix 1 Mandatory Specifications and Optional Requirements to the CASSAR System, to the Statement of Work are supportive to the above response:

Mandatory Technical Specifications sections:

- 2.1 The system must be capable of **detecting and locating** a fully-functional cell phone, when the cell phone is not in contact with a commercial cellular network, at a minimum **line of sight range of 20 kilometers from the aircraft when the aircraft is an altitude between 3000 to 10000 feet above ground**:
- **2.6** The system must be capable of **geo-locating** a cellular "phone of interest" which is not connected to a commercial cellular network regardless of whether or not Global Positioning System (GPS) data is available from the cell phone.

Optional Technical Specifications sections:

- **3.3** The system should be capable of **detecting and tracking multiple target cell phones** (potentially for use in communicating to Ground Search and Rescue (GSAR) parties as well as the "phone of interest");
- **3.4.2** The system should be able to provide a **mass-mapping capability** of cell phone locations in an area with no cellular infrastructure.

And;

Mandatory Design Specifications sections:

- **4.2** The system must have a system **currently in use for Search and Rescue purposes** on an aircraft within a NATO allied air force or a Five Eyes (FVEY) partner;
- **4.3** The system **must be stand-alone** and the internal antenna(s) must operate through the aircraft windows **without external modifications to the RCAF Primary Air Vehicles** (PAV) on which the equipment will be used:
