PART 1 - GENERAL INFORMATION

1.1 Introduction

The bid solicitation is divided into seven parts plus attachments and annexes, as follows:

- Part 1 General Information: provides a general description of the requirement;
- Part 2 Bidder Instructions: provides the instructions, clauses and conditions applicable to the bid solicitation;
- Part 3 Bid Preparation Instructions: provides Bidders with instructions on how to prepare their bid;
- Part 4 Evaluation Procedures and Basis of Selection: indicates how the evaluation will be conducted, the evaluation criteria that must be addressed in the bid, and the basis of selection;
- Part 5 Certifications and Additional Information: includes the certifications and additional information to be provided;
- Part 6 Security, Financial and Other Requirements: includes specific requirements that must be addressed by Bidders; and
- Part 7 Resulting Contract Clauses: includes the clauses and conditions that will apply to any resulting contract.

The Annexes include the Requirement, the Basis of Payment, and the Electronic Payment Instruments.

1.2 Summary

The Department of National Defence (DND), CFB Trenton requires equipment as detailed under Article 6.2 of the resulting contract clauses.

1.3 Debriefings

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days from receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

1.4 epost Connect service

This bid solicitation requires bidders to use the epost Connect service provided by Canada Post Corporation to transmit their bid electronically. Bidders must refer to Part 2 entitled Bidder Instructions, and Part 3 entitled Bid Preparation Instructions, of the bid solicitation, for further information.

PART 2 - BIDDER INSTRUCTIONS

2.1 Standard Instructions, Clauses and Conditions

All instructions, clauses and conditions identified in the bid solicitation by number, date and title are set out in the [Standard Acquisition Clauses and Conditions Manual](https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual) (<https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual>) issued by Public Works and Government Services Canada.

Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract.

The 2003 (2020-05-28), Standard Instructions - Goods or Services - Competitive Requirements, are incorporated by reference into and form part of the bid solicitation.

Subsection 5.4 of 2003, Standard Instructions - Goods or Services - Competitive Requirements, is amended as follows:

Insert: 120 days

2.2 Submission of Bids

Bids must be submitted only to the Public Works and Government Services Canada (PWGSC) Bid Receiving Unit specified below by the date and time indicated on page 1 of the bid solicitation:

Only bids submitted using epost Connect service will be accepted. The Bidder must send an email requesting to open an epost Connect conversation to the following address:

TPSGC.oreceptiondessaoumissions-orbidreceiving.PWGSC@tpsgc-pwgsc.gc.ca

Note: Bids will not be accepted if emailed directly to this email address. This email address is to be used to open an epost Connect conversation, as detailed in Standard Instructions 2003, or to send bids through an epost Connect message if the bidder is using its own licensing agreement for epost Connect.

It is the Bidder's responsibility to ensure the request for opening an epost Connect conversation is sent to the email address above at least six days before the solicitation closing date.

Bids transmitted by facsimile or hardcopy to PWGSC will not be accepted.

2.3 Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than seven (7) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

2.4 Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Ontario.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidders.

2.5 Bid Challenge and Recourse Mechanisms

- (a) Several mechanisms are available to potential suppliers to challenge aspects of the procurement process up to and including contract award.
- (b) Canada encourages suppliers to first bring their concerns to the attention of the Contracting Authority. Canada's [Buy and Sell](#) website, under the heading "[Bid Challenge and Recourse Mechanisms](#)" contains information on potential complaint bodies such as:
- Office of the Procurement Ombudsman (OPO)
 - Canadian International Trade Tribunal (CITT)
- (c) Suppliers should note that there are **strict deadlines** for filing complaints, and the time periods vary depending on the complaint body in question. Suppliers should therefore act quickly when they want to challenge any aspect of the procurement process.

PART 3 - BID PREPARATION INSTRUCTIONS

3.1 Bid Preparation Instructions

The Bidder must submit its bid electronically in accordance with section 08 of the 2003 standard instructions. The epost Connect system has a limit of 1GB per single message posted and a limit of 20GB per conversation.

The bid must be gathered per section and separated as follows:

Section I: Technical Bid
Section II: Financial Bid
Section III: Certifications

Bids transmitted by facsimile or hardcopy will not be accepted.

Section I: Technical Bid

In their technical bid, bidders should explain and demonstrate how they propose to meet the requirements and how they will carry out the Work.

Section II: Financial Bid

3.1.1 Bidders must submit their financial bid in accordance with Annex "B", Basis of Payment.

3.1.2 Electronic Payment of Invoices – Bid

If you are willing to accept payment of invoices by Electronic Payment Instruments, complete Annex "D" Electronic Payment Instruments, to identify which ones are accepted.

If Annex "D" Electronic Payment Instruments is not completed, it will be considered as if Electronic Payment Instruments are not being accepted for payment of invoices.

Acceptance of Electronic Payment Instruments will not be considered as an evaluation criterion.

PART 4 - EVALUATION PROCEDURES AND BASIS OF SELECTION

4.1 Evaluation Procedures

- (a) Bids will be assessed in accordance with the entire requirement of the bid solicitation including the technical and financial evaluation criteria.
- (b) An evaluation team composed of representatives of Canada will evaluate the bids.

4.1.1 Technical Evaluation

4.1.1.1. Mandatory Technical Criteria

The Bidder must demonstrate that their proposed equipment meets or exceeds the following Mandatory Technical Evaluation Criteria. For each specification listed, the bidder must include a reference to supporting technical documents included with their bid, such as literature, brochures and/or specifications for their proposed equipment, where it is clearly demonstrated that their proposed equipment meets the specification. If any of the equipment specification is missing from the supporting technical documentation, then the Bidder must provide a narrative to demonstrate how the equipment meets that particular specification.

4.1.2 Financial Evaluation

4.1.2.1 Mandatory Financial Criteria

Any bid which fails to meet the following mandatory financial criteria will be deemed nonresponsive and will receive no further consideration:

- a) Bids must not contain any alteration to Annex "B" - Basis of Payment, other than the addition of the Manufacturer and Model information for the Item and the Bidder's firm unit pricing for all items. Bidders must provide the manufacturer and model information and the firm unit pricing for all items in their bid.
- b) Bids must not contain any condition or qualification placed upon the bid.
- c) Pricing must be firm in Canadian currency, excluding applicable taxes, and must not be indexed or tied to an escalation factor.
- d) Pricing must be provided for all items as listed in the Pricing Basis. If the Bidder leaves any price blank, Canada will treat the price as "\$0.00" for evaluation purposes and may request that the Bidder confirm that the price is, in fact, \$0.00. No Bidder will be permitted to add or change a price as part of this confirmation. Any Bidder who does not confirm that the price for a blank item is \$0.00 will be declared non-responsive.

4.1.2.2 Financial Evaluation

The price of the bid will be evaluated in Canadian dollars, Applicable Taxes excluded, Delivered Duty Paid, Canadian customs duties and excise taxes included.

The Bidder's Firm Unit Price will be multiplied by the quantity to calculate the extended pricing.

The Evaluated Price, used to determine lowest bid, will be the sum of the extended pricing of Annex B.

4.2 Basis of Selection

A bid must comply with all requirements of the bid solicitation and meet all mandatory technical evaluation criteria and financial evaluation criteria to be declared responsive. The responsive bid with the lowest evaluated price will be recommended for award of a contract.

PART 5 – CERTIFICATIONS AND ADDITIONAL INFORMATION

Bidders must provide the required certifications and additional information to be awarded a contract.

The certifications provided by Bidders to Canada are subject to verification by Canada at all times. Unless specified otherwise, Canada will declare a bid non-responsive, or will declare a contractor in default if any certification made by the Bidder is found to be untrue, whether made knowingly or unknowingly, during the bid evaluation period or during the contract period.

The Contracting Authority will have the right to ask for additional information to verify the Bidder's certifications. Failure to comply and to cooperate with any request or requirement imposed by the Contracting Authority will render the bid non-responsive or constitute a default under the Contract.

5.1 Certifications Required with the Bid

Bidders must submit the following duly completed certifications as part of their bid.

5.1.1 Integrity Provisions - Declaration of Convicted Offences

In accordance with the Integrity Provisions of the Standard Instructions, all bidders must provide with their bid, **if applicable**, the Integrity declaration form available on the [Forms for the Integrity Regime](http://www.tpsgc-pwgsc.gc.ca/ci-if/declaration-eng.html) website (<http://www.tpsgc-pwgsc.gc.ca/ci-if/declaration-eng.html>), to be given further consideration in the procurement process.

5.2 Certifications Precedent to Contract Award and Additional Information

The certifications and additional information listed below should be submitted with the bid but may be submitted afterwards. If any of these required certifications or additional information is not completed and submitted as requested, the Contracting Authority will inform the Bidder of a time frame within which to provide the information. Failure to provide the certifications or the additional information listed below within the time frame specified will render the bid non-responsive.

Certifications are subject to verification by Canada during the entire period of the Contract.

7.9 Applicable Laws

The Contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Ontario.

ANNEX “A”, REQUIREMENT

1. System Operation

1.1. Environment

The 3D scanners will be housed within a temperature controlled building when not deployed. Typical day to day use will be within the maintenance shops for Rapid Prototyping tasks, and for training of members for deployed tasks. When deployed, it will typically be used in controlled environments, with limited use in dusty/dirty environments that are not temperature controlled. There is no intent to use the device in extremes of cold/hot or wet environments. Typical environmental operating temperature will be 5 – 40°C @ <90% Humidity non-condensing. Transport of device will likely be in a sealed pelican case or similar.

1.2. Concept of Support

Technical and software support, and repair must be available from the OEM, with both technical and user training available, utilized as needed.

1.3. Key Roles

Operation of the system must be simple for the end user, with setup and operation possible with minimal training. Output product can be passed onto specialists for additional processing. Minor system maintenance and repair will be conducted by Unit Support elements trained and certified in the care and maintenance of the system, while major overhaul and repairs will be conducted by the OEM or Authorized retailer / repair facility.

1.4. Project Interdependencies

No direct interdependency with other projects and equipment, other than the output product of the 3D scanner must be able to be directly 3D printed, and manipulated in CAD based modeling programs, such as SolidWorks, Autodesk Fusion 360, AutoCAD, etc.

2 Scanner requirements

2.1 General Requirement

DND requires a single output device (Laptop) to connect to both a light and laser based scanner, due to the range of different materials that will be required to be scanned, and the complimentary advantages of light and laser based scanners.

2.2 Laser based Scanner

- (j) Must not require external positioning or tracking devices such as the CMM, multi-articulated arms, laser plotters, GPS, electromagnetic positioning devices, or any other external positioning system for the part or scan head;
- (k) Must be a single unit and operable with one hand;
- (l) Must not weigh more than 1.5 kg without accessories and carrying case;
- (m) Must possess a volume of less than 0.05 m³ without accessories and carrying case;
- (n) Must be equipped with Class II lasers;
- (o) Must have a maximum stand-off distance of 500mm with indication;

- (p) Must measure parts with a maximum resolution of at least 0.05 mm (based on the standard ASME B89.4.22);

2.3 Light Based Scanner

The light based scanner must meet or exceed all of these specifications:

- (c) Must allow real-time visualization of the scanning area on the surface of the object during the data acquisition phase;
- (d) Must allow an optimized mesh to be exported in all standard formats (at a minimum, .stl and .obj), immediately after the acquisition;
- (e) Must allow multiple user-defined/selected resolutions, which can be changed at any time before or after scanning;
- (f) Must automatically eliminate anomalous surface markers during the analysis process;
- (g) Must allow interactive editing of erroneous data or unwanted areas during surface scanning;
- (h) Must automatically create an optimized scan file using data acquisition and conversion software;
- (i) Must be capable of merging surface scans taken across multiple scan sessions;

- (r) Must measure parts with a maximum volumetric accuracy of at least 0.02 mm + 0.09 mm/m (based on the standard ISO 10360);
- (s) Must have a scanning area of greater than 0.04 m2;
- (t) Must have a measurement rate greater than 400,000 measures/s;
- (u) Must use a USB 3.0 or USB-C port to connect to the computer and include compatible cable of at least 4 metres; and
- (v) Must provide portable carrying case compatible with airline carry-on restrictions that can contain the scanner and accessories.

2.4 The 3D-scan data acquisition and conversion software

The 3D-scan data acquisition and conversion software must meet or exceed the following specifications:

- (a) Allow the following automatic and manual mesh modifications: clean meshes, fill holes, merge meshes, decimate meshes, and make meshes watertight;
- (b) Allow an alignment of the scanned data in order to use the data/entities in a way suited for the reverse engineering projects;
- (c) Allow the generation of non-uniform rational bases spline (NURBS) surfaces and the extraction of the mesh entities to automatically characterize freeform surfaces;
- (d) Allow the acquired data to be exported to a CAD platform (Autodesk Inventor; SolidWorks, etc.) using the following standard formats: Initial Graphics Exchange Specification (IGES), Standard for the Exchange of Product (STEP), and Drawing Exchange Format (DXF);
- (e) Display real-time visualization of forms obtained by the scanner during the data acquisition phase; and
- (f) Be able to merge the surface analyses taken in separate scanning sessions.
