AMENDMENT 004

This amendment is to publish a new series of Questions and Answers (Q&A) related to the Requirement and to modify the Requirement (Annex A).

Question 8: For a server-based monitoring software the users will be able to access the software via an internet connection if the Canadian Food Inspection Agency (CFIA) provides them with VPN login. Will VPN access be provided?

Answer 8: Yes. VPN access is provided to all CFIA users by the CFIA.

Question 9: If Cloud software is acceptable, Users can access the software directly with an internet connection using a secure login. Is Cloud storage and software interface an acceptable alternative to in-house server?

Answer 9: Please refer to Solicitation document Amendment 002, question/answer #3.

Question 10: Is a NIST traceable calibration certificate acceptable or does the calibration certificate have to be ISO 17025?

Answer 10: Please refer to Solicitation document (000), Annex A, criterion 4.21. It is clearly indicated that probes must be calibrated by a minimum of one accredited calibration provider to meet the requirements of ISO / IEC 17025.

Question 11: Must or can a written proposal be included with the quotation?

Answer 11: Yes. Please refer to Solicitation document (000) Part 3 – Bid Preparation Instructions.

Question 12: What is the installation timeframe? Start date? End date? Will work be expected to be completed on weekends? After hours? Or during regular business hours?

Answer 12: Please refer to Solicitation document (000) Part 2, section 2.1.2. Delivery/installation is requested as soon as possible. All installation details will be given once the contract is awarded to the winning bidder.

Question 13: Is local support in the Montreal area important or required? Do you require English/French service personnel?

Answer 13: Please refer to the new section 8 of Annex A (see below).

Question 14: Do you require 24/7 response time? If not, what is the expected response time?

Answer 14: Please refer to the new section 8 of Annex A (see below).

Question 15: Do alarm notification also need to be generated by CALL SMS/TEXT?

Answer 15: No. This is not required.

Question 16: Do you want to monitor Webcams?

Answer 16: No.

Question 17: Do you want to monitor any 3rd party sensors? Gas detection? Ph?

Answer 17: No, as indicated in the Annex A, the required system has to monitor and record the temperatures and CO2 concentrations of laboratory equipment and premises of the CFIA.

Question 18: Does the system need to be validated? IQ/OQ/PQ?

Answer 18: No

Question 19: Does the software need be FDA CFR 21 Part 11? GAMP5?

Answer 19: No

Question 20: Will this project be reusing any existing sensors?

Answer 20: No.

Question 21: Do you require color-coded alarm bands to be visible on the chart view of the data for quick analysis of alarm conditions?
