Q1) Are security services such as control of access traffic, standing security guard service at the gate, and monitoring security camera included in PMFS Embassy of Canada in Tokyo Solicitation # 08C54-190430/C?

We recognize that the content of SOW3.12 does NOT include professional security service.

A1) No. Only those activities identified under 3.12 pertain to this solicitation.

Q2) PMFS bit does NOT include neither professional security service nor professional security service fee because Protective services for the Embassy of Canada in Japan (21-183330-TOKYO-CJ) includes security service such as control of access traffic, standing security guard service at the gate, and monitoring security camera.

A2) These activities do not form part of this solicitation or PFMS requirements as they are contracted for separately.
