## AMENDMENT 002

The purpose of this amendment is to answer questions from suppliers.

### Question 10

Section 4.1.2.1.2 PRE-AWARD SAMPLES AND SUPPORTING DOCUMENTATION, A), refers to 1 SBT Helmet being required if the helmet is a one-size-fits-all helmet but in Section 4.1.2.1.3, END USER TRIAL EVALUATION SAMPLES, it is referring to 2 SBT helmets being required along with the wipes and anti-fog treatment and makes no mention of the helmet bag. Can the customer please clarify how many total samples of each item are required with submission and if any samples are required at any other point of the evaluation?

### Answer 10

Both the items listed under Section 4.1.2.1.2 Pre-Award Samples and Section 4.1.2.1.3 End User Trial Evaluation are required with the bid submission. Each helmet must be provided in a protective bag.

### Question 11

#### 6.1.4 Replaceability

The SBT Helmet must have a lens that can be easily replaced by RCMP personnel without return to the manufacturer. Replacement must be possible with commonly available tools that are not proprietary to the manufacturer. Other parts that may easily become detached or damaged, such as **foam padding, must also be replaceable.**

Please confirm if Bid will be non-compliant and will receive no further consideration if foam padding are permanently fixed.

Note: No parts are considered to be easily detached or damaged.

### Answer 11

Permanently fixed foam padding will be acceptable.

### Question 12

6.3.7 Storage Bag - Each SBT Helmet must come with a drawstring bag to carry and store the helmet. The storage bag must cover the entirety of the SBT Helmet when closed. The bag **must be** made of a woven, **lightweight (60 – 120 g/m<sup>2</sup>)**, breathable synthetic fabric. The bag must be machine washable and materials must not scratch, abrade or otherwise damage the SBT Helmet.

Please confirm if Bid will be non-compliant and will receive no further consideration if storage bag weight is more than 120g/m<sup>2</sup>.

Note: We consider this to be critical and highly desirable for longer durability of the item.

### Answer 12

Fabrics up to a maximum weight of 200g/m<sup>2</sup> will be acceptable.

In Annex B Purchase Description and Annex C Evaluation Grid:

**6.3.7 Storage Bag** – Each SBT Helmet must come with a drawstring bag to carry and store the helmet. The storage bag must cover the entirety of the SBT Helmet when closed. The bag must be made of a woven, lightweight (60 – 120 g/m<sup>2</sup>), breathable synthetic fabric. The bag must be machine washable and materials must not scratch, abrade or otherwise damage the SBT Helmet.

Delete: 120g/m<sup>2</sup>

Insert: 200g/m<sup>2</sup>

### **Question 13**

6.4.4 Anti-microbial and Anti-fungal

a) SBT Helmet materials must be mildew-resistant for the warranted life of the helmet. Materials must be inherently mildew-resistant or must be treated with an anti-fungal that lasts the warranted life of the helmet.

Please confirm if Bid will be non-compliant and will receive no further consideration if we are not compliant with this requirement.

Note: Instructions are provided in user manual regarding cleaning procedure.

### **Answer 13**

The requirement for anti-microbial will be removed from the mandatory criteria and will become an optional criteria. If the manufacturer chooses to apply an anti-microbial product to their helmet, the requirements of para. 6.4.4 b. will apply.

In Annex B Purchase Description and Annex C Evaluation Grid:

6.4.4 a) SBT Helmet materials must be mildew-resistant for the warranted life of the helmet. Materials must be inherently mildew-resistant or must be treated with an anti-fungal that lasts the warranted life of the helmet.

### **Question 14**

2.3 American Society for Testing and Materials

ASTM F1776-18 Standard Specification for Eye Protection Devices for Paintball Sports

Please confirm if Bid will be non-compliant and will receive no further consideration if our helmet is not qualified for this requirement.

Note: Our product is designed and certified for use with Simunition training system.

### **Answer 14**

The product does not need to be certified to or meet all requirements of ASTM F1776-18. Test reports are only required for the following sections of ASTM F1776-18: section 7.2.4 (lens retention), section 7.4 (protective surface impact), and section 4.1.1 (field of view).

**Question 15**

6.2.1.2 Conducted Energy Weapon (CEW) - Conducted Energy weapon training cartridges will be 6.35 mm (1/4 in.) long barbs and a maximum velocity of 48.8 m/s (160.1 fps) and weight of 3 g.

Please confirm if Bid will be non-compliant and will receive no further consideration if we can guarantee this requirement.

Note: Our product is designed and certified for use with Simunition training system.

**Answer 15**

The conducted energy weapon barb may penetrate the helmet material, however, materials which allow for the cylindrical portion of the probe to penetrate do not meet this requirement.

**Question 16**

6.4 Materials

The SBT Helmet materials must meet the requirements of ASTM F2879-16 Sections 5.1.2., 5.1.3, 5.1.4.

Please confirm if Bid will be non-compliant and will receive no further consideration if our helmet is not qualified for this requirement.

**Answer 16**

A letter of attestation must be provided by the bidder stating that the helmet will meet the following requirements from ASTM F2879-16:

5.1.2 Materials exposed to sunlight shall not undergo significant loss of physical properties.

5.1.3 Materials coming into contact with the wearer's face shall not be of a type known to cause skin irritation.

5.1.4 Materials coming into contact with the wearer's face shall not undergo significant loss of strength, flexibility, or other physical change as a result of perspiration, oil, or grease from the wearer's skin and hair.
