**Questions and Answers:**

**Question 1:** For Mandatory criteria M3, there is a requirement that all 3 past projects presented in the bid must have had a minimum \$1,000,000 budget and have all the other criteria. Would the client consider opening up the criteria in M3 to accept past projects presented by the bidder with a lower minimum budget requirement (example) \$500,000?

**Answer 1:** Canada Day event is a major national event that includes many different aspects of event production. Because of that, it has been decided that the minimum budget requirement for M3 is \$1,000,000.

**Question 2:** Would you consider extending the period of past experiences? If not, could you explain why it is limited to 2009?

**Answer 2:** The past experiences that will be considered in the RFP process at M3 must have been done after January 1, 2009 to be able for the bidder to demonstrate examples of events that are technologically relevant to today's methodologies.
