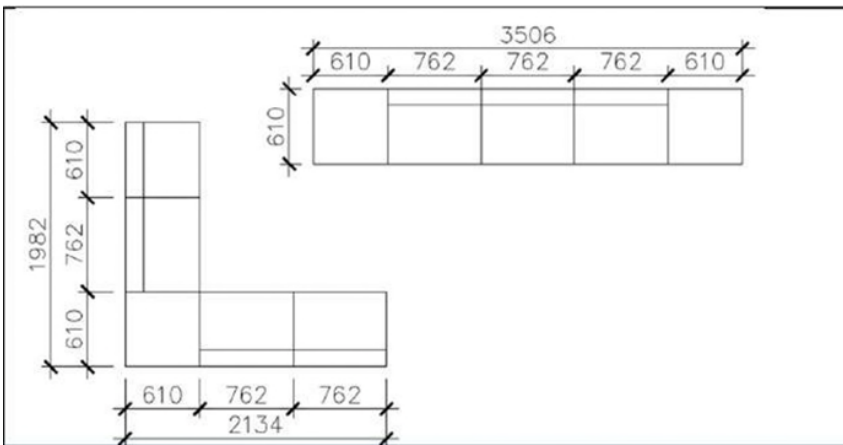
QUESTIONS/ANSWERS

You are asking for a square benches 24 x 24, our benches with full depth (to line up with modular seating) is 23"x26".

Another issue is that the gov't code for this item is for Individual seat with mid back, while specs on bid point out no back. The units with no backs are not standard.

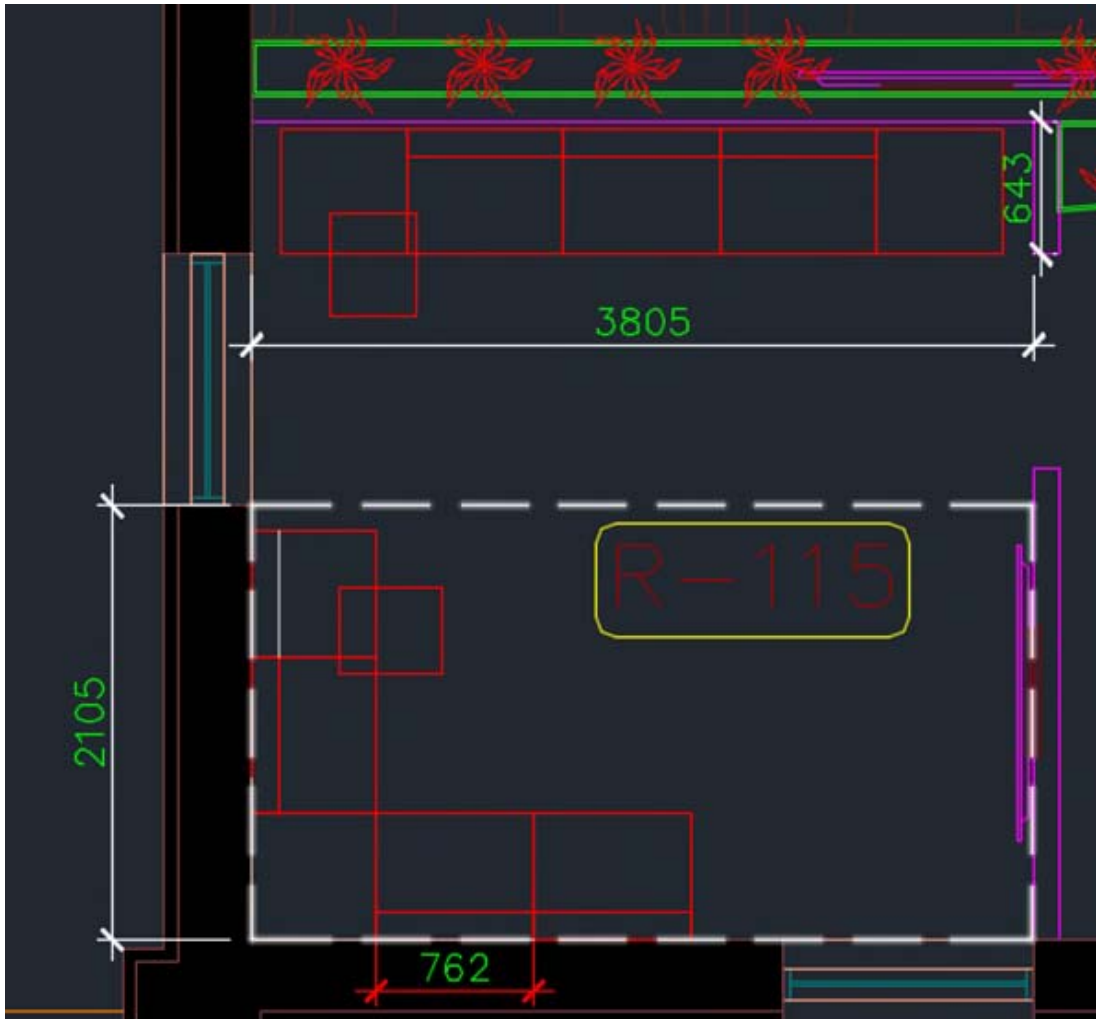
Would you accept the 3 units with backs?




A1. We need 3 modules without back that are 24 " wide. We can accept module that are 23" wide but they must not be more than 25" deep. We also need 30" wide modules.

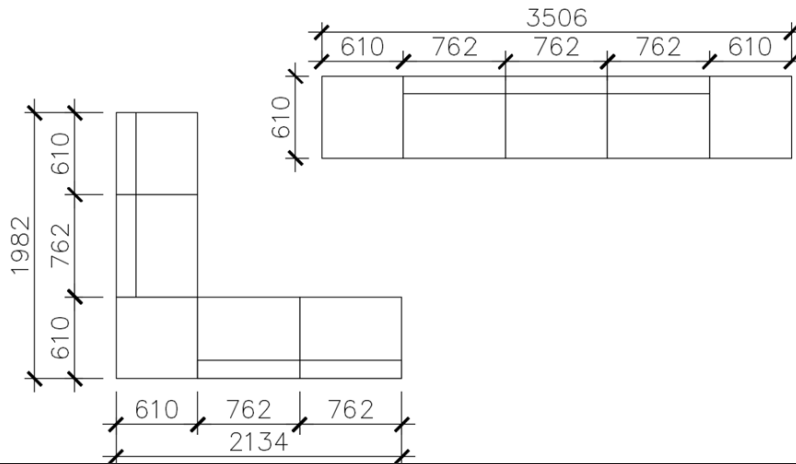
