Question 38

Do we need to submit a quote for stream 2 if we want to offer hybrid online tutoring that include some self-learning modules? Or would it be possible to propose this offer in stream 4?

Answer 38

An Offer for Stream 2 must include all services requested for this stream as described in the Statement of Work, Annex A. Stream 4 is for tutoring only. It is the Offerors' responsibility to determine which services they can offer.

Can we offer pricing for additional services (placement test to determine the resources to be used, access fees for platforms complementary to the online courses, etc.)?
