Description of the Requirement:

Health Canada (HC) – Corporate Services Branch (CSB), in conjunction with the Real Property and Security Directorate, is responsible for all HC custodial and non-custodial buildings across Canada. As part of this responsibility HC engages, funds and oversees service providers to deliver real property related construction, repair and building systems and sub-system maintenance in six custodial laboratories in the National Capital Region (NCR).

1.1. Objectives of the Requirement

Health Canada has an immediate need for one (1) Real Property Intermediate Project Manager and one (1) Real Property, Senior Project Manager with the knowledge and experience in program and health & safety management that will ensure the timely delivery of projects. Projects will vary in size, complexity and location. “Typical” projects are within the existing laboratories and will include but is not limited to, restoration, renovation, new fit-up, system repair and system upgrade.
