Can the client confirm if 1920x1080 @ 60Hz would be the maximum required resolution for their setup?

Answer 3

Yes, we confirm the following: 1920x1080 @ 60Hz would be the maximum required resolution.

Question 4

We have a question regarding solicitation Cables for the Department of Employment and Social Development Canada (2BH074927A):

-Reference to Annex A, line item 2 “ 6 feet DisplayPort to DVI-D Dual Link (25 pin) M/M cable “

And

-Amendment 1, Answer 1 says “Our standard monitors are 1920x1080 @60Hz with a response time of 5ms”

Question: Single-Link DVI-D can support a screen resolution up to 1920x1200 at 60Hz whereas a Dual-Link DVI can support a screen resolution up to 2560x1600 at 60Hz or 1920x1080 at 144Hz. According to your requirement Dual-Link DVI-D seems to be unnecessary.

So, for line item 2, would you accept 6 feet DisplayPort to DVI-D single Link (19 pin) M/M cable?

Answer 4

Yes, a Single link DVI-D to DP M/M 6 feet cable is acceptable.

Modification 2
